

### 1. License Agreement and Terms

- A. The producers listed here are referred to in this agreement as the Film Partners (“Film Partners”).
  - a. Love Worth Finding Ministries, Inc.
  - b. John Sanders, LLC
  - c. Eidon Events, Inc.
- B. The church or ministry group receiving this License is referred to as the Licensee (“Licensee”).
- C. LWF has made arrangements with the Film Partners to grant this special, limited use license for **Nothing But The Truth – The Church Experience** (“the Film”) at no cost to the Licensee subject to this agreement and terms.
- D. The term of this agreement is 1 year from the date the film license is agreed to and materials are delivered.
- E. While the film is offered at no cost for churches, Love Worth Finding requests that the Licensee consider a donation of any amount to LWF to help cover the costs of producing and distributing the film, and continued production of ministry materials. Donations can be sent to Love Worth Finding by:

  - c. Online – visit <https://lwf.org/nbttloveoffering> and your gift will be recorded for the Film.
- F. The Licensee is granted the non-exclusive right during the Term to exhibit the Film on the Licensed Premises for an unlimited number of showings. The first screening of the Film under this license constitutes acceptance of all the terms of this limited license.
- G. As used in this license, “Licensed Premises” means the Licensee’s own facilities or a venue outside of such facility that is officially considered a location for the Licensee’s ministry program, AND each showing is hosted by leadership from the Licensee’s ministry, AND the Film is not loaned to another ministry or organization. Additional venues not meeting these conditions require a separate license.

### 2. Conditions and Considerations for Use of the Film:

- A. The intent of this license is for churches, or other Christian ministry groups, to be able to exhibit the film in a local, congregational setting. It is not intended for individual use. DVDs of the film can be purchased from the LWF online store ([lwf.org/store](http://lwf.org/store)). At the end of the Film, Film viewers will also be presented with a way to acquire individual DVDs or digital copies.
- B. Except for a free will “love offering” taken on behalf of Love Worth Finding, no charges shall be made, directly or indirectly, for the screening of the Film or admission to the whole of the Licensed Premises.
- C. No cutting, editing, alteration or adaptation of the Film is allowed.

### 3. Assignment of Rights

The rights granted in this License Agreement may not be licensed or assigned to any third party.

### 4. Duplication, Distribution, Streaming, and Broadcasting

Nothing in this License Agreement shall be construed as a license to copy the Film, to issue copies of the Film to the public, to rent or lend the Film to the public, to communicate the Film to the public (including without limitation by way of broadcast or making available by electronic transmission), or to perform, show or play the Film in public other than in accordance with the terms of this License Agreement.

### 5. Termination

The Film Partners may terminate this License Agreement with immediate effect by notice in writing to the Licensed Group if the Licensees does not honor the terms of this License Agreement.

## 6. Use of Information

Use of personal information or information regarding the Licensee that is provided in acquiring this License Agreement (the "Information") may be used by the Film Partners for the purposes of administering this License Agreement and subsequent participation in church exhibition licensing programs administered by the Film Partners. By accepting this License Agreement, the Licensee Group agrees to the use of Information in this manner.

## 7. Liability

The Film Partners shall not be liable to the Licensee Group for any type of financial, special, indirect or consequential loss under this License Agreement.

## 8. Other Terms (for the lawyers)

- A. Nothing in this License Agreement shall constitute an agency, partnership or joint venture between the Film Partners and the Licensed Group.
- B. This License Agreement shall constitute the entire agreement between the Film Partners and the Licensed Group relating to the subject matter of this License Agreement.
- C. No variation of this License Agreement shall be valid unless it is in writing and signed by or on behalf of each of the Film Partners and the Licensed Group.
- D. Any claim or dispute arising from or related to this agreement shall be settled by mediation and, if necessary, legally binding arbitration in accordance with the Rules of Procedure for Christian Conciliation of the Institute for Christian Conciliation (complete text of the Rules is available [www.iccpeace.com](http://www.iccpeace.com) or by contacting ICC PEACE at [info@iccpeace.com](mailto:info@iccpeace.com)). Judgment upon an arbitration decision may be entered in any court otherwise having jurisdiction. The parties understand that these methods shall be the sole remedy for any controversy or claim arising out of this agreement and expressly waive their right to jury and their right to file a lawsuit in any civil court against one another for such disputes, except to enforce an arbitration decision.
- E. The failure to exercise or delay in exercising a right or remedy under this License Agreement shall not constitute a waiver of the right or remedy or a waiver of any other rights or remedies, and no single or partial exercise of any right or remedy under this License Agreement shall prevent any further exercise of the right or remedy or the exercise of any other right or remedy.
